2026 NRA DIRECTOR NOMINATIONS

The nominees for election to the NRA Board in 2026 have been selected by the Nominating Committee and by petition of the membership.

The Board consists of 76 Directors. The Bylaws require that one-third of the terms of office of 75 Directors shall expire at each Annual Meeting of Members. One Director is elected for a one-year term at each Annual Meeting of Members. This Director is selected from the candidates who were not elected by the mail ballot.

The 2026 election will fill the 25 three-year terms that expire in 2029; three two-year terms that expire in 2028; and one one-year term that expires in 2027. Voting members will vote for a total of 29 candidates. The 25 candidates receiving the highest number of votes will be elected to three-year terms; the three candidates receiving the next highest number of votes will be elected to two-year terms; and the one candidate receiving the next highest number of votes will be elected to a one-year term.

Nominations by the Nominating Committee. The Committee reviewed fifty-three candidates, including incumbents seeking re-election, members who submitted themselves for consideration or who were recommended by other NRA members, and candidates who had begun the process of seeking nomination by petition. Thirty candidates were selected.

Nominations by Petition of the Membership. Eleven people were nominated by petition (three of the eleven had already been nominated by the Nominating Committee). Each petition sponsored by an NRA member or member organization required the signatures of not less than 363 voting members.

The 2026 Ballot. Prior to the ballots being printed, two of the Nominating Committee candidates withdrew their names from consideration. A total of 38 candidates, the combined total from the Nominating Committee and petition of the members, appears on the ballot. **The NRA Bylaws require the names to be rotated on the ballot. Five different ballots with five different orders of names were printed. The biographical sketches that follow were written by the individual nominees. They appear here in alphabetical order; however, the names on the ballots are in a different order because of the Bylaws requirement to rotate the order of names.**

To Expedite Voting, begin by looking at the first name on the ballot. Then locate the name on the alphabetical list of biographical sketches. This procedure is much faster than reading the biographical sketch first and then trying to locate the name on a ballot NOT printed in alphabetical order.

LT. COL. WILLIAM E. BAILEY, USAR (RET.) MILLEDGEVILLE, GEORGIA

Lifelong outdoorsman with a deep passion for shooting, hunting, and fishing. Interest in firearms began early, guided by family and mentors who instilled respect for safe and skilled gun handling. Over the years, collected and competed with rifles, pistols, shotguns, and muzzleloaders, earning classification as a Master level High Power and Long Range shooter, a CMP Distinguished Rifleman, and awarded the President's Hundred tab. Served 30 years in the Georgia Army National Guard, U.S. Army Reserve, and Active Duty, retiring as a Lieutenant Colonel in 2021. A dedicated dog handler, trained and hunted with Beagles, Feists, and a German Shorthaired Pointer across the country in pursuit of upland game. Served as past President of the Georgia Sport Shooting Association.

MR. ROBERT BECKMAN CINCINNATI, OHIO

Proudly dual nominated by the members and Nominating Committee. NRA Benefactor member, training counselor, NRA-FAL/ILA, volunteer for FONRA in SE-Indiana, and dedicated Second Amendment advocate.

Professional IT project manager, experienced with implementing enterprise systems in legal, finance, operations, manufacturing, audit, and organizational change management. A devoted husband of 37 years, father, and grandfather. The host/creator of the Firearm Trainer Podcast, and VP/Hunting Director for the Ohio Rifle and Pistol Association. Former board member and current adult leader for the local Boy Scout council. Selected for the 2025 NRA Annual Meetings "Voices of the Second Amendment" and guest on numerous podcasts. Proud member of numerous pro-gun/conservation organizations including SCI, IALEFI, NSSF, NMLRA, FPC, GOA, GOAL, CNJFO, OGCA, BHA, RMEF, NDA, Boone & Crockett Club, NTA, OSTA, F4WM, IHEA, NMSSA, NKSSA, Buckeye Firearms, League of Ohio Sportsmen, League of Kentucky Sportsmen, Indiana State Rifle and Pistol Association, and the Illinois State Rifle Association.

MAJ. GEN. KENNETH BOWRA, USA (RET.) SMITHFIELD, VIRGINIA

Graduated from The Citadel. Retired as a Major General after over thirty-three years of service in the United States Army. Commanded Special Forces units at all levels including

serving as a reconnaissance team leader in MACV-SOG during Vietnam service conducting long range operations against deep North Vietnamese targets; Commander ODA-572 "Green Light" Special Atomic Demolitions (SADM) High Altitude Low Opening (HALO) Special Forces Detachment; Commander Company B, 2-75 Ranger Battalion. Conducted operations in Cambodia, Grenada, Somalia and Afghanistan. Appointed as a senior Foreign Service Officer in the Department of State in February 2009 and was assigned to the U.S. Embassy, Riyadh, Saudi Arabia, where he directed a Department of State Interagency Counter Terrorist Program. Inducted into the Special Forces Hall of Fame as a Distinguished Member of the Regiment. An Eagle Scout and Scout leader, actively supported Scouting in assignments.

MR. CHARLES BROWN DAYTON, OHIO

A lifelong Second Amendment career (third generation) developing communication, compliance & problem-solving skills over 35 years in business. An avid shooter, bow hunter, and fisherman. BBA in Marketing and Management from University of Cincinnati, 1984.

LT. COL. ROBERT K. BROWN, USAR (RET.) DENVER, COLORADO

Founder, former editor/publisher, Soldier of Fortune Magazine. From NRA Resolution: "WHEREAS SOLDIER OF FORTUNE magazine has been uncompromising in supporting the Second Amendment through its right-to-keep-and-bear-arms editorial policy and public appearances [and] played a prominent role in electing pro-gun political leaders [and] originated the concept of a rifle, pistol, and shotgun tactical match; and in the course of 21 years hosted a total of more than 10,000 individual competitors." OIC Army Marksmanship Unit, and pistol team member. Rifle team member, Ft. Leonard Wood. Special Forces Captain, Vietnam, 1969, awarded Combat Infantry Badge, Purple Heart, Bronze Star. Because I advocated to change, NRA saved \$500,000 a year by bringing in-house the digital production of America's 1st Freedom magazine. DOD letter: "By bringing back the first AK74 5.45 ammunition ... tested by [DOD] you helped immensely in adding to our knowledge of Soviet small arms developments." Big game hunter, four continents.

MR. ALEX CARROLL CONNERSVILLE, INDIANA

Mr. Carroll's decades of entrepreneurial success include founding Lifeline Data Centers (180,000 sq. ft., expanding by another 50,000 sq. ft.) with patented in-house HVAC and power systems, owning

a real estate development firm with more than 550,000 sq. ft., owning a commercial construction company, and scaling his consulting practice to 10,000+ annual billable hours annually, serving private and public sectors since 1994. For over a decade, he has advanced military readiness and warfighter safety through civilian contracts, developing a DFARS/ CMMC compliance platform—now the national gold standard—enabling DoD contractors to inherit 80% of NIST 800-171 controls cost-effectively, plus patented EMP shielding for critical infrastructure. He has similarly supported law enforcement for over a decade via secure data centers, emergency readiness facilities, and technology platforms ensuring operational continuity and cybersecurity. A lifelong agriculturist, he grew up on an Indiana farm and in 2024 opened a cattle slaughterhouse supporting local producers.

Former coach/captain of numerous Navy and civilian pistol teams. Committee assignments: Chair of Competition Rules & Programs, and Pistol. Serves on Air Gun, Collegiate Programs, Military & Veterans Affairs, and Protest Committees. Forty plus year history enhancing shooting programs and supporting competitors at all levels. NATIONAL RIFLE ASSOCIATION OF AMERICA REPORT OF THE NOMINATING COMMITTEE

The Nominating Committee met via Microsoft Teams online video conferences on May 19, May 29, June 30, July 31, and August 14, 2025. The Committee is deeply grateful for the service of members Maria Heil, who resigned in May for personal reasons, and Robben Love, who died unexpectedly on August 4. Both members made significant contributions to the Committee's work during the time they were able to serve.

At its meeting on May 19, 2025, the Committee elected Owen Buz Mills as Chairman and Al Hammond as Vice Chairman.

At its meeting on June 30, 2025, the Committee unanimously adopted the following motion:

MOVED, that the Committee recommends that the Board waive the disqualification under Article IV, Sec. 1(a)(3) for Thomas Arvas, Mark Robinson, and Steven Schreiner.

At its meeting on August 14, 2025, the Committee unanimously adopted the following resolution:

WHEREAS, it is in the best interest of the National Rifle Association that the Association's voting members choose from the best-qualified candidates to meet the organization's current and future challenges, and

WHEREAS, the Director Nomination Policy adopted on January 11, 2025 requires the Nominating Committee to "identify and memorialize a list of desired qualities and skills which it seeks

in director candidates for the upcoming year," and

WHEREAS, the Nominating Committee has met with the Association's President, First and Second Vice Presidents, and Executive Vice President to discuss the criteria for candidates for the 2026 election of directors; therefore,

BE IT RESOLVED, that the Committee shall seek to identify candidates for the 2026 ballot who possess the following qualities:

- Unquestioned personal integrity;
- Passion for the NRA's mission;
- Proven executive-level leadership abilities;
- A record of entrepreneurial success;
- Financial, investment, insurance, and risk management experience;
- Experience in NRA program areas such as competitive shooting and gun collecting;
- Firearms industry experience and relationships;
- Strong communication skills, social media influence, and willingness to serve as the public face of the Association;
- Proven ability to connect with emerging constituencies such as younger gun owners and members of minority groups; and
- Available time to devote to NRA business.

The Committee met at NRA Headquarters in Fairfax, Virginia on August 23, 2025, for the purpose of

nominating individuals for election to the NRA Board of Directors in 2026. Members present were: Owen Buz Mills, Chairman; Al Hammond, Vice Chairman; Cam Edwards; Mitzy McCorvey by teleconference; Janet Nyce; and Susan Springhorn. Committee member Robert J. Wos was unable to attend. John C. Frazer was present as the committee secretary.

The Nominating Committee is a screening process designed to determine the most qualified candidates to be recommended to NRA voting members for election to the NRA Board of Directors. The Committee made every effort to select the best possible candidates for nomination. Service on the NRA Nominating Committee is an honor and a serious responsibility. The Committee has an obligation to select those candidates who are the most dedicated, best qualified, and have the expertise and freedom needed to best serve the needs of the NRA and its members.

The Committee reviewed 53 candidates, including incumbents seeking re-election, members who submitted themselves for consideration or who were recommended by other NRA members, and candidates who had begun the process of seeking nomination by petition.

The proceedings of the Nominating Committee took place in executive session.
